



Q104 (CFRQ) "Password to Paradise" - Rules and Regulations

1. **CONTEST PERIOD:** Every day **January 14th – 25th, 2019**
Two winners will be announced on **Friday, January 25th**
2. **ELIGIBILITY:** The "Contest" is open to all residents of Nova Scotia, who are 19 years of age or older with a valid ID, excluding employees of Q104, Stingray Radio Inc.
